A liquor license for addition of optional premises application was filed with the Local Licensing Authority on June 9, 2021, and a "Notice of Hearing" was posted on the property on or before noon on September 1, 2021.

A survey was conducted to address the reasonable requirements of the neighborhood. The neighborhood was defined on the north by Independent Avenue, on the south by Grand Avenue, on the east by N 1st Street and on the west by 25 Road. The results are as follows:

Twenty entries were disqualified for the following: out of the designated area (12), not 21 years of age (7), and a duplicate entry (1).

To date, no letters of opposition or counter petitions have been filed.

The Grand Junction Police Department will investigate the individuals for local criminal history. Reports have also been requested from the City of Grand Junction Sales Tax Department, the Fire Department, and Mesa County Health Department.

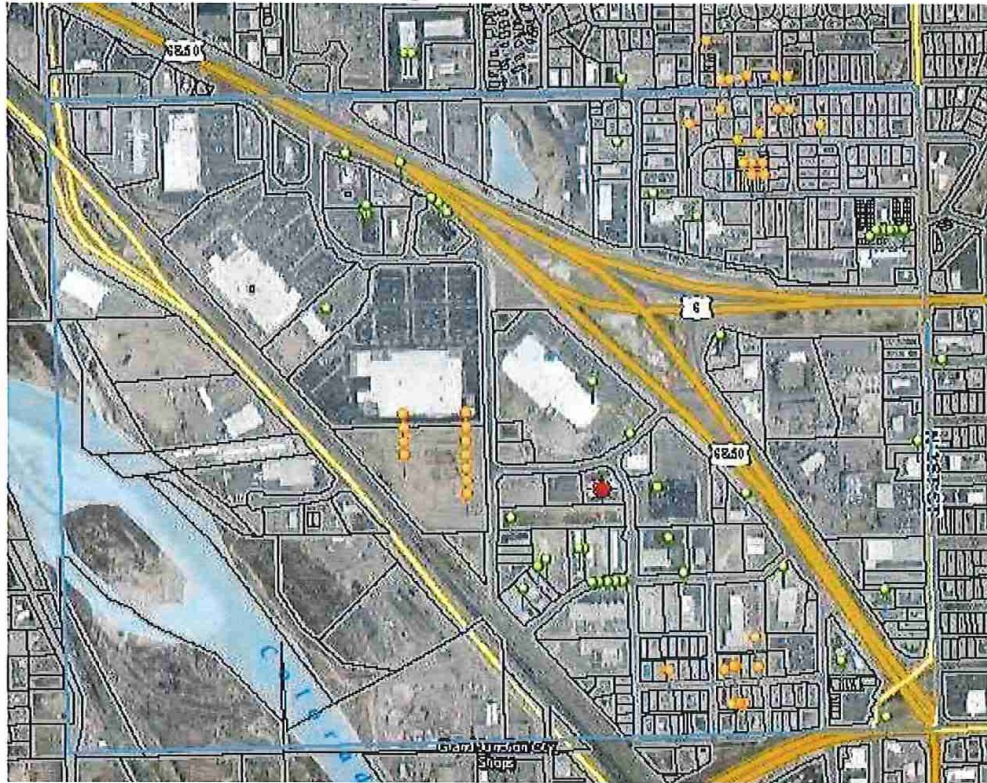

ORDINANCE NO. _____

**AN ORDINANCE AMENDING THE GRAND JUNCTION MUNICIPAL CODE BY
ESTABLISHING A PROCESS FOR OPTIONAL PREMISES LICENSES IN THE CITY
OF GRAND JUNCTION, COLORADO AND AMENDING ORDINANCE NO. 5010
CONCERNING THE STATUTORY CITATIONS THEREIN**

Recitals:

The Grand Junction Municipal Code at 5.12.010 et. seq. provides *inter alia* that the Hearing Officer shall determine after hearings in accordance with the State liquor and beer codes certain applications for licensure and apply established legal principles to those applications. With this Ordinance, the City Council does establish a process for optional premises licenses in the City of Grand Junction, Colorado.

Colorado law (§§44-3-310 and 413 C.R.S.) permits a municipality to pass an ordinance to provide optional premises license(s) for an applicant to sell, dispense or serve alcohol beverages at location(s) designated by the applicant and approved by the Local Licensing Authority and the State. The service area must be designated annually and upon designation of the area(s) for service no alcohol beverages may be served without the licensee having provided 48 hours' notice prior to serving.

Service of alcohol beverages at and within designated area(s) of existing licensees may be shown to benefit the patrons of the licensed facility and so long as the service of alcohol is done lawfully and with full benefit of professional management, supervision and regulation the City Council authorizes the Local Licensing Authority to accept, evaluate and decide Optional Premises license applications. As determined by the City Clerk in consultation with the City Attorney this ordinance shall be codified in the Grand Junction Municipal Code as 5.12.245

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

For the purposes of this ordinance, the following words or phrases shall have the meanings set forth. Additions to the GJMC are shown in ALL CAPS.

- a. *OPTIONAL PREMISES LICENSE* MEANS THE SAME AS THAT DEFINED IN THE COLORADO LIQUOR CODE UNDER § 44-3-310(4) AND 44-3-413, C.R.S.
- b. *OPTIONAL PREMISES APPLICANT OR OPTIONAL PREMISES LICENSEE* MEANS THE SAME AS THAT DEFINED IN THE COLORADO LIQUOR CODE UNDER § 44-3-310(4) AND 44-3-413, C.R.S.

C) AN APPLICANT FOR AN OPTIONAL PREMISES LICENSE SHALL FILE WITH THE CITY CLERK THE FOLLOWING INFORMATION IN ADDITION TO INFORMATION, REQUIRED BY THE STATE (APPLICATION).

D) WHEN THE APPLICATION IS COMPLETE AND ACCEPTED AS TO FORM BY THE CITY CLERK THE APPLICATION WILL BE SCHEDULED AND HEARD PUBLICLY BY THE GRAND JUNCTION LIQUOR LICENSING AUTHORITY (LOCAL AUTHORITY) THE APPLICATION SHALL INCLUDE AND DESCRIBE:

- (1) AN ILLUSTRATION OF THE OPTIONAL PREMISES AREA/SIZE/BOUNDARIES AND THE LOCATION OF THE PROPOSED OPTIONAL PREMISES LICENSE REQUESTED, THAT THE OPTIONAL PREMISES LICENSE SHALL NOT BE EXERCISED TO INTERFERE WITH PUBLIC ACCESS OR INHIBIT THE SAFETY OF PERSONS USING/ACCESSING THE FACILITY(IES); AND
- (2) A DESCRIPTION OF THE METHOD WHICH SHALL BE USED TO IDENTIFY THE BOUNDARIES OF THE OPTIONAL PREMISES LICENSE WHEN IT IS IN USE AND HOW THE LICENSEE WILL ENSURE ALCOHOL BEVERAGES ARE NOT REMOVED FROM SUCH PREMISES; AND,
- (3) A DESCRIPTION OF PROVISIONS, INCLUDING A DESCRIPTION OF FACILITIES, WHICH HAVE BEEN MADE FOR STORING THE ALCOHOL BEVERAGES IN A SECURED AREA ON OR OFF THE OPTIONAL PREMISES AND FOR FUTURE USE ON THE OPTIONAL PREMISES IF OR WHEN ALCOHOL BEVERAGES ARE NOT SERVED INCLUDING THAT ALL ALCOHOL WILL BE STORED IN THE DESIGNATED AND APPROVED AREAS IN THE OPTIONAL PREMISES;
AND,
- (4) A DESCRIPTION OF THE PROVISIONS WHICH WILL BE IMPLEMENTED TO CONTROL OVER SERVICE, PREVENT UNDERAGE SERVICE OF ALCOHOL BEVERAGES AND FOR FOOD SERVICE; AND,
- (5) A DESCRIPTION OF THE OPERATIONAL RELATIONSHIP BETWEEN THE LICENSED PREMISES AND THE OPTIONAL PREMISES, INCLUDING BUT NOT LIMITED TO THAT THE APPLICANT IS THE OWNER; AND,
- (6) AN OATH OR AFFIRMATION THAT THE LICENSEE SHALL AT ALL TIMES WHEN EXERCISING THE LICENSE ADHERE TO THE APPLICABLE REQUIREMENTS AND ALL OTHER STANDARDS APPLICABLE TO THE CONSIDERATION AND/OR ISSUANCE OF LICENSES UNDER THE COLORADO LIQUOR CODE AND ANY AND ALL APPLICABLE LOCAL LAWS, RULES AND REGULATIONS.

E) NOTHING CONTAINED IN THIS ORDINANCE SHALL PRECLUDE THE LOCAL AUTHORITY IN ITS DISCRETION, FROM IMPOSING CONDITIONS, RESTRICTIONS,

OR LIMITATIONS ON AN OPTIONAL PREMISES LICENSE IN ORDER TO PROTECT THE PUBLIC HEALTH, SAFETY AND WELFARE. ANY SUCH CONDITIONS MAY BE IMPOSED WHEN THE LICENSE IS INITIALLY ISSUED, ISSUED FOR ANY SPECIFIC EVENT, OR RENEWED. THE AUTHORITY SHALL HAVE THE RIGHT TO DENY ANY REQUEST FOR AN OPTIONAL PREMISES LICENSE OR IT MAY SUSPEND OR REVOKE THE OPTIONAL PREMISES LICENSE IN ACCORDANCE WITH THE PROCEDURES SPECIFIED BY LAW.

F) IT SHALL BE UNLAWFUL FOR ALCOHOL BEVERAGES TO BE SERVED ON THE OPTIONAL PREMISES UNTIL THE OPTIONAL PREMISES LICENSEE HAS FILED WRITTEN NOTICE WITH THE STATE AND THE LOCAL AUTHORITY STATING THE SPECIFIC DAYS AND HOURS DURING WHICH THE OPTIONAL PREMISES WILL BE USED. NOTICE MUST BE FILED WITH THE STATE AND LOCAL AUTHORITY 48 HOURS PRIOR TO SERVING ALCOHOL BEVERAGES ON THE OPTIONAL PREMISES. SUCH NOTICE SHALL CONTAIN THE SPECIFIC DAYS AND HOURS ON WHICH THE OPTIONAL PREMISES WILL BE USED FOR THE CONSUMPTION OF ALCOHOL BEVERAGES.

Furthermore, this Ordinance amends Ordinance No. 5010 by replacing the citations to the former Colorado Liquor Code, C.R.S. 12-47-101 *et seq.* contained in Ordinance No. 5010 with the current citations expressed in C.R.S. 44-3-101 *et. seq.*

If any clause, sentence, paragraph, or part of this Ordinance or the application thereof to any person or circumstances shall for any reason be adjudged by a court of competent jurisdiction invalid, such judgment shall not affect the remaining provisions of this Ordinance.

The City Council finds and declares that this Ordinance is promulgated and adopted for the public health, safety and welfare and this Ordinance bears a rational relation to the legislative object sought to be obtained.

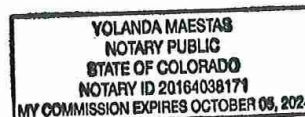

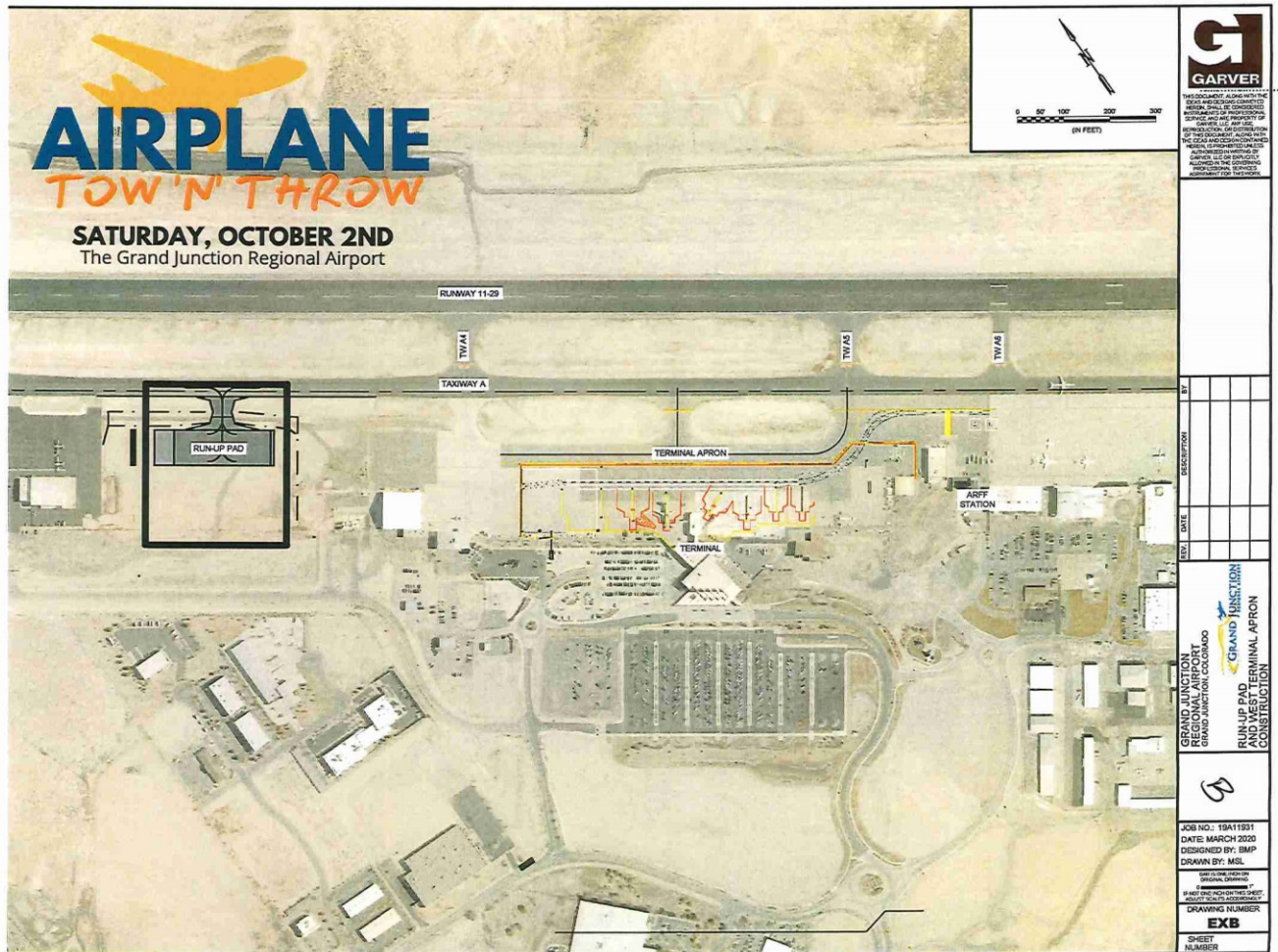

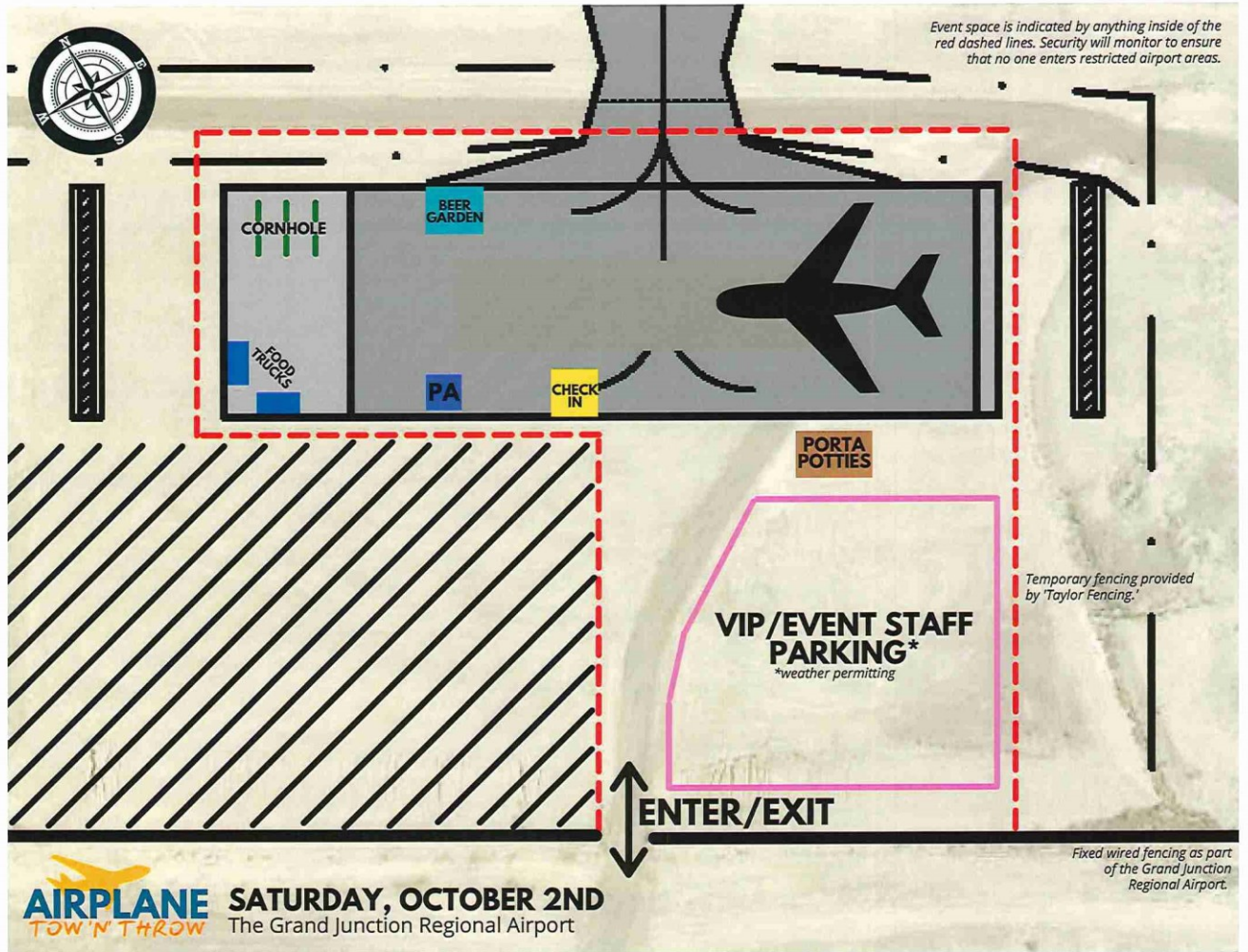

Members from The Greater Grand Junction Sports Commission and United Way of Mesa County nonprofit organizations will make up 10 "event staff" personnel. This includes the organization's full time staff as well as part time employees and interns.

Event day volunteers will also be present to assist with security needs. Volunteers are being recruited from local nonprofit organizations, such as RSVP, and the general public. A total of 20 volunteers will be at the event with 5 of those volunteers specifically assigned to the beer garden area. Event day volunteer duties include assisting with parking needs, registration check in, and ensuring that no one leaves the event/beer garden area with an alcoholic beverage. Beer garden volunteer duties will include assisting with checking IDs, pouring beers, and processing payment transactions.

Additionally, airport staff from TSA and the Department of Homeland Security will act as another layer of security for the event. Chance Ballegeer, Airport Security Coordinator, will manage and oversee the 5-6 airport staff that will be present. He can be reached at 970-248-8586 or cballegeer@qjairport.com.

In total, there will be roughly 35 individuals made up of event staff, volunteers, and airport staff that will be present on event day as security.

7. Describe the Security Control Plan.

The Greater Grand Junction Sports Commission and United Way of Mesa County will collaborate with Chance to coordinate an appropriate security control plan. He has indicated that the security control plan is similar to that of the West Star Aviation's Air Show. His staff will constantly be moving around, monitoring all aspects of the event, as well as using radios to communicate with dispatch from Station 6 if necessary. Each airport staff member is properly trained at the standards deemed appropriate by the Grand Junction Regional Airport. Their primary responsibility will be to ensure everyone's safety and that no one attempts to enter restricted airport areas. These areas are indicated by anything outside of the red temporary fencing located on the newly updated and improved site map, attached.

The Grand Junction Regional Airport and Taylor Fencing will be assisting in fencing needs. A 6' chain link fence will run along the north side of the airport's runway pad to further ensure that no one enters the restricted airport area. Although barriers are already in place on the east and west sides of the runway pad, temporary fencing will run from these barriers to connect with the black fixed fencing located at the south end area.

8. How will security personnel be identified?

All security personnel, including event staff, volunteers, and airport staff, will be easily identifiable. Event staff will wear their organization's shirt with an identifiable logo either from the Greater Grand Junction Sports Commission or United Way of Mesa County. Limited event staff will also be badged. These two event staff members include Executive Directors, Ben Snyder from the Grand Junction Sports Commission and Zebulon Miracle from United Way of Mesa County. Both have successfully completed a specific training program and background check deemed appropriate by the Grand Junction Regional Airport in order to receive their badge.

Event day volunteers will be required to wear bright, neon yellow shirts that identify them as such provided by the Greater Grand Junction Sports Commission. Additionally, all airport staff will be dressed in their standard issued uniform and personal ID badge, making them easily identifiable by any involved participant or spectator.

10. What method of age verification will be used and how will underage patrons be identified so as not to be served alcohol beverages?

Beer garden staff and volunteers will use an individual's drivers license to properly verify his or her age for those that wish to partake in alcohol consumption. The procedure of age verification will be conducted at the designated beer garden tent and volunteers will be properly trained on how to do so by the certified tip trained personnel.

Those that are of appropriate drinking age will be given a wristband and required to wear it throughout the event. Those that are underage will not be given a wristband but a giant black "X" marked across the top of their hand instead. These individuals will not be permitted to partake in alcohol consumption.

11. How will the conduct and level of intoxication of attendees be monitored and by whom?

The conduct and level of intoxication of attendees will be heavily monitored by event staff, volunteers, and airport security. Beer garden staff, volunteers, and certified tip trained personnel will be properly and appropriately trained to ensure that no one is overserved. Additionally, airport staff and security will constantly and thoroughly monitor the beer garden area as well as those partaking in alcohol consumption.

12. Have the volunteers or members of your organization been trained in the sale/service of alcohol beverages?

Members of our organizations and event day volunteers will be properly trained in the sale and service of alcoholic beverages. Zebulon Miracle, the Executive Director of United Way of Mesa County, and his wife will be certified tip trained personnel. Additionally, Cassidy Veach, the Outreach & Event Coordinator from the Greater Grand Junction Sports Commission will also

be a certified tip trained personnel. All three individuals have successfully earned their "Seller Server Training - On/Off Premises" certification from the official Alcohol Beverage Training organization. These designated tip trained individuals will properly and effectively train any and all other beer garden staff and volunteers involved.

Furthermore, 1-2 staff members from Rockslide Brewery & Restaurant may be present during the event to assist in the training of beer garden staff and volunteers as well as security. Their presence will be determined on event day depending on the restaurant's busyness that day.

Other Questions + Answers

The information below are additional event details that may be useful to know or be aware of that were not part of the questions needing further explanation indicated above.

- The beer garden will operate from 10:00am-4:00pm.
- Alcohol will be delivered to the event site less than one hour before the beer garden operation officially begins. Tip trained personnel and beer garden staff will set up the two kegs donated by Rockslide Brewery & Restaurant in the designated beer garden area in the event space as well as monitor them for security purposes.
- The designated beer garden will consist of two 10'X10' tents, two tables (*one under each tent*), two kegs, a cash box (*to take paper payments*), and a Square (*to take electronic payments*).
- The purpose and mission of the 'Airplane Tow N Throw' event is to bring the community together and help fundraise for over 25 local nonprofits. Profits from the event, including but not limited to those from the beer garden and event registration, will be used to distribute among said nonprofits.
- Expected number of attendees is roughly 600 people. This includes participants (*assuming 20 teams of 20 individuals*), spectators, event staff, volunteers, and airport security personnel.
