

**GRAND JUNCTION LIQUOR LICENSING AUTHORITY
MINUTES
DECEMBER 1, 2021**

I. Call to Order

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Sam D. Starritt, City Attorney John Shaver and Deputy City Clerk Selestina Sandoval.

SUBJECT: Board Fox Games, LLC dba Board Fox Games, LLC – 623 Main Street, Grand Junction, CO 81501

A liquor license application permitting sales of malt and vinous beverages for consumption at place where sold, was filed with the Local Licensing Authority on September 1, 2021, and a “Notice of Hearing” was posted on the property on October 8, 2021.

A survey was conducted to address the reasonable requirements of the neighborhood. The neighborhood was defined on the north by Grand Ave, on the south by South Avenue, on the east by 9th Street and on the west by 4th Street. The results are as follows:

Business Results:

FAVOR: 103

OPPOSE: 0

Residential Results:

FAVOR: 25

OPPOSE: 1

One entry was disqualified for being out of the designated area and eight were disqualified due to incomplete entries.

According to exhibit forms included in petition forms eight people refused to sign, 149 addresses were attempted without signatures due to no answer/no soliciting signs/other and one due to no one available over the age of 21.

To date, no letters of opposition or counter petitions have been filed.

The Grand Junction Police Department will investigate the individuals for local criminal history. Reports have also been requested from the City of Grand Junction Sales Tax Department, the Fire Department, and Mesa County Health Department.

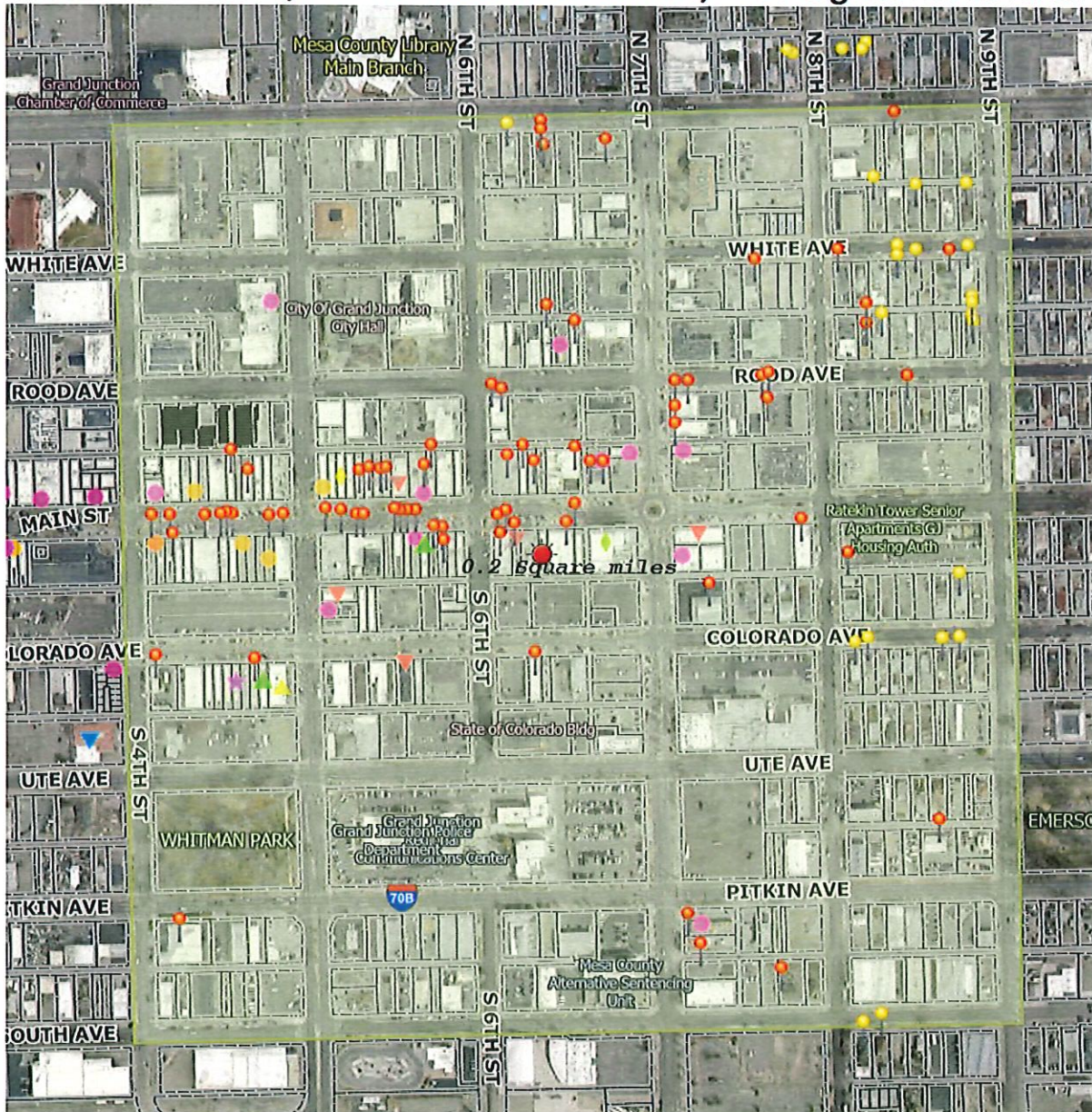

SUBJECT: Canyon View Resort, LLC dba Canyon View RV Resort – 746 23 ½ Rd, Grand Junction, CO 81505

A liquor license application permitting sales of fermented malt beverages in sealed containers not for consumption at place where sold, was filed with the Local Licensing Authority on October 25, 2021 and on November 17, 2021 a legal notice was published in the Daily Sentinel and a "Notice of Hearing" was posted on the property.

A survey was conducted to address the reasonable requirements of the neighborhood. The neighborhood was defined on the north by H Road, on the south by G Road, on the east by 24 Road and on the west by 23 Road. The results are as follows:

Business Results:

FAVOR: 49
OPPOSE: 0

Residential Results:

FAVOR: 27
OPPOSE: 1

Four entries were disqualified for incomplete entries.

According to exhibit forms included with petitions 29 addresses had no trespassing signs posted/locked gates, and 25 addresses had no answer/were unoccupied/closed to the public due to COVID-19.

To date, no letters of opposition or counter petitions have been filed.

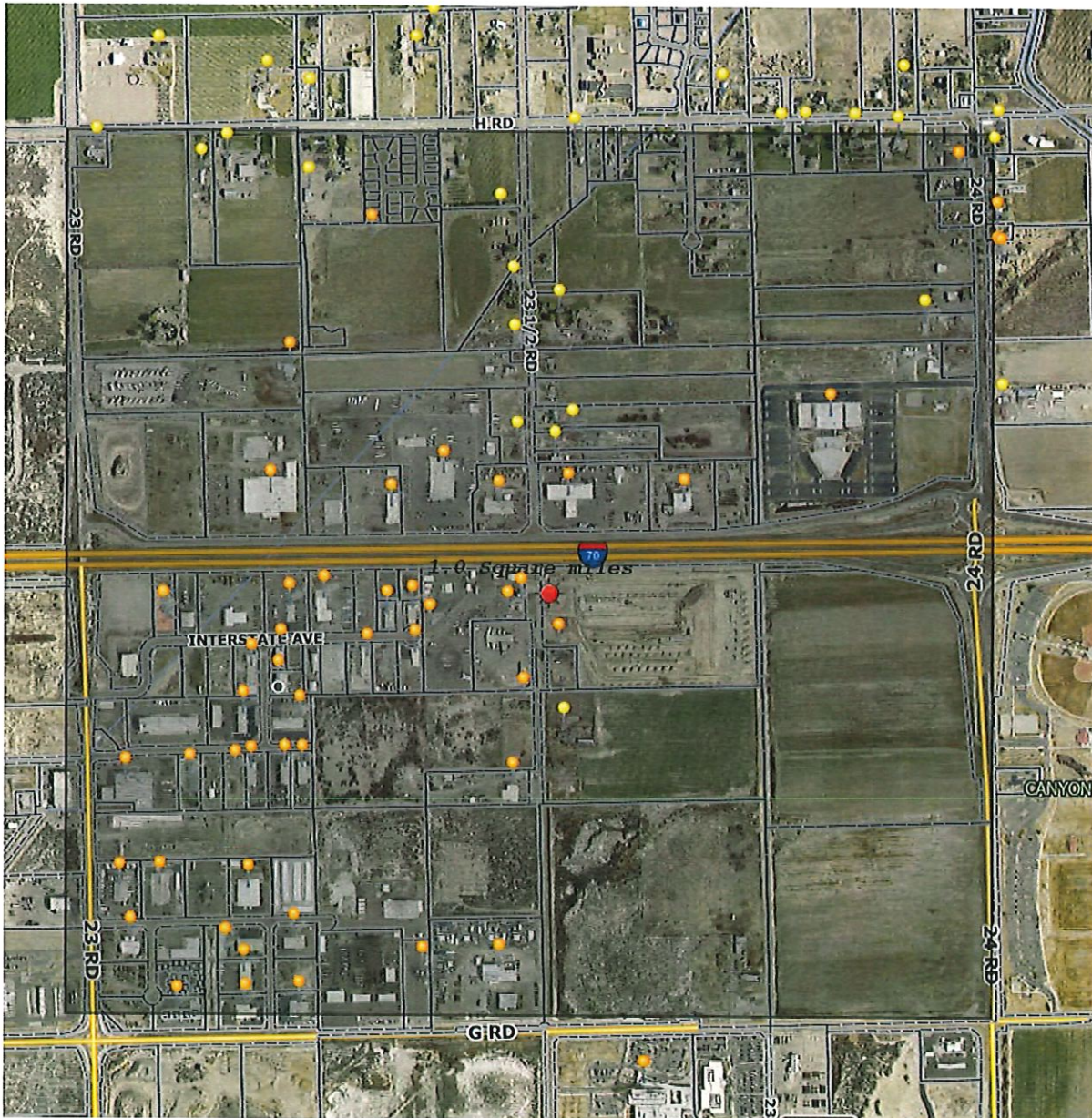
