

GRAND JUNCTION LIQUOR LICENSING AUTHORITY
MINUTES
July 5, 2023

I. Call to Order

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Sam D. Starritt (via phone), City Attorney John Shaver, and Deputy City Clerk Janet Harrell.

II. License Renewal Applications

2. Old Chicago Taproom II, LLC dba Old Chicago #27, 120 North Avenue, Grand Junction, CO 81501, Hotel & Restaurant
3. Fisher's Liquor Barn, Inc. dba Fisher's Liquor Barn, 2438 Patterson Road, Grand Junction, CO 81505, Liquor Store and Tasting Permit
4. Junction Liquors, LLC dba Fun Junction Liquors, 510 28 ¾ Road, Units 202-205, Grand Junction, CO 81501, Liquor Store and Tasting Permit

Event Manager Miquette Gerber was present and answered a series of questions regarding the event location, security, and how it will be conducted lawfully. Hearing Officer Starritt verified with Ms. Harrell the application was in order and asked if there was anyone present to speak against the application. He entered Exhibits "A," "B" and "C" (attached) into the record.

Hearing Officer Starritt found that pursuant to Colorado State Statute 44-5-106, there are no grounds to deny the special event permit; it would not be injurious to

the public welfare because of the nature of the special event, its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable laws. The application for the special event permit submitted by Rotary Club of Grand Junction - Horizon Sunrise for "Rhythm and Brews Concert Series - 2023" was in order and approved.

3. Has the event been held in the past? If so, how many years? Yes but HSR wasn't a part of it

4. Have there ever been any violations or citations issued during the event in the past?

See attached drawing. Main Street Grand Junction between 3rd and 7th.

6. What type of and how many security will be provided?

Citadel Security will be hired and will roam the event. They will have direct radio contact to GJPD dispatch

7. Describe the Security Control Plan (use additional sheet if necessary).

At every egress point, at least 1 person will be posted wearing a high-viz vest to prevent alcohol from leaving the venue. Volunteers will be checking valid forms of identification to ensure those trying to purchase a drink token are above age 21. ID checking and alcohol serving will be separate areas.

8. How will security personnel be identified?

Citadel security will be wearing loged uniforms. Access/egress monitors will be wearing high-viz vests.

9. If this event is an outdoor event, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?

Pedestrian fencing and barriers will be used to control exterior boundaries.

Signs saying "No Alcohol Beyond This Point" will be posted also.

10. What method of age verification will be used (i.e., at the door, at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.)? A

Everyone appearing to be under the age of 55 will be asked for a valid form of identification so age can be confirmed by event staff. Once the event staff have confirmed a person is more than 21 years old, they will issue a wrist band that will then allow people to purchase beer tokens for exchange for a beverage.

11. How will the conduct and level of intoxication of attendees be monitored and by whom?
Loud or slurred speech, unsteady/uneven walking/standing, inappropriate behavior, etc.

12. Have the volunteers or members of your organization been trained in the sale/service of alcohol beverages?
Yes, many members of our club have been through the City's Liquor Server Training on multiple occasions

13. What other types of beverages and food/snacks will be available?
Restaurants will be open and many food truck vendors will be at the event.
